Vocational Support Services

Vocational Training was provided to 46 Columbus Community Center clients who are able to perform a wide range of process and packaging tasks in the Columbus Production Services (CPS) warehouse, located in West Valley City. This work moved to the organization's Main building and the warehouse was subsequently sold in April 2021. Additional training was provided to 34 clients in the Organization's secure shredding facility. Also, training was provided to 39 clients in the Contract Services program, encompassing work at the Intermountain Healthcare Laundry in North Salt Lake and grounds and janitorial work at facilities throughout the Salt Lake Valley. During FY20, the organization provided vocational support services to 119 individuals.

Residential Services

Residential services are provided to approximately 56 clients at a time, ranging from medically fragile to reasonably independent in seven facilities located in the Salt Lake area. Some of the residential facilities are staffed 24 hours daily, while other residential facilities are staffed as needed to provide occasional assistance to clients. During FY20, the organization provided residential services to 59 individuals.

The second program is the NextWork Autism program. During FY20 this program provided assessments, classes, and employment services to 58 individuals

with autism. In FY21, 10 clients were able to move into the new HUB of Opportunity building in which NextWork now operates.

The third program is Columbus Connects. This program is funded by USOR (Utah State Office of Rehabilitation) and provided PRE-ETS (pre-employment and transition services) services to students ages 14-21 years old. We served 220 students in FY20.

In total, the Community Employment department served 358 individuals in FY20.
